1. **THE PARTIES** : Chandrakona Vidyasagar Mahavidyalaya , Chandrakona , Paschim Medinipur , West Bengal is signed a MOU with the Garhbeta College on 12.04.22 . The MOU in view of exploring the possibilities between the parties in terms of Faculty /Student /Staff exchange programme for mutual benefit of both the institutions. The MOU is effective from. 12.04.2022 to establish an affiliation by and between Garhbeta College and the present college. Having an expertise in the area of inter exchanging lectures delivered having its office at Chandrakona Vidyasagar.Mahavidyalaya here in after CVM , the First party .

And

Garhbeta College, under Vidyasagar University having its office located at Garhbeta, Paschim Midnapur here in after referred to as GC, of the second party, for the purpose of exchange of faculty for academic purpose. The said institution is here in after referred to individually as Institute and collectively as Institutes.

2. **BACK GROUND OF MOU** : Whereas, the UGC (Promotion and Maintenance of Standards of Academic Collaboration between two Colleges) Regulations, 2016, mandate framing of collaboration policy of the UGC consistency hereto.

Where As, the inter exchanging of higher education is providing an ever growing range of opportunities for encouragement with universities and Colleges in the nearer Colleges.

Whereas, to create a strong and viable teaching system for the well being of the students as envisaged under the Policy of NAAC.

3. **GENERAL** : CVM and GC. have many teachers in different subjects such as English, History , Education...Physical education, Bengali, Philosophy etc. Now Therefore, CVM and GC have decided to enter into this MOU which defines the framework for the cooperation of the Two Colleges set out in the following sections.
4. **PROPOSED OBJECTIVES AND EXPECTED OUTCOMES** : In consideration of the mutual promises set forth in this MOU , both Colleges are agree to the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity. The objectives of the MOU are as follows.  
The College shall enter into the MOU for any one or more of the following objectives :-
  - a) To prioritize the inclusive growth of the society and combing priorities of excellence and relevance.
  - b) To encourage the mobility of experts from academia and vice-versa.
  - c) To device scheme for fostering academia –student partnership.
  - d) To foster resource optimized, cost-effective innovations for the needs of humanity.
  - e) To increase the standard of academic arena as well as standard of education and to improve the quality of education.
  - f) To create a robust mutual understanding for the betterment of the students.
5. **FACULTY EXCHANGE PROGRAMME** : A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed. Terms and conditions for each visit or an assignment or such exchange, including those concerning Travelling Allowance and any other matter related to it will be worked out between the Two Colleges on the mutual basis. A separate agreement will be entered into giving such details including term of exchange of any intellectual
6. A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed. Terms and conditions for each visit or an assignment or such exchange, including those concerning Travelling Expenses / Tiffin expense will be worked out between the Institutes on the mutual basis. A separate agreement will be entered into giving such details including term of exchange of any intellectual property.

Terms & conditions for each visit or an assignment or such exchange, including shortest travel costs will be borne by the Institute(s). A separate agreement will be entered into giving such details including term of exchange of any intellectual property.
7. **STUDENT EXCHANGE** : CVM and GC agree that student exchange will be guided by principles listed below.



The home Institution refers to the Institution i.e. CVM, where a student is a full time student and from where he / she is expected to be Graduate. A host Institution refers to an Institution GC that receives a student for a brief period of time to undertake a pre-determined programme of study or research.

8. **DURATION / VALIDITY / TERMINATION AND RENEWAL** : This MOU shall remain in force for a period of **02 (Two) years** commencing from effective date. However, this period may vary from area of collaboration and collaborative programmes. Institutions may extend the term by another written agreement signed by both after review of the same.

9. **IMPLEMENTATION AND MONITORING** : Both the institutes shall on a regular basis, keep each other informed of and consult on procedure, progress and objective achieve or planned.

The institutes shall set specific timeline before and establish manner of monitoring and review of the execution of the area of cooperation and its objectives.

For proper implementation of all criteria and timely completion of the agreed objectives, the CVM may constitute a monitoring committee. The monitoring committee will review the annual progress of the collaboration and give suggestions if required. However, both institutes will arrange six monthly mutual meeting to discuss the proper implementation and goal(s) achieved during the period. The CVM monitoring committee will consist the following members.
